October 6, 2021

A scheduled general meeting of the Green Valley Arts and Crafts Association was held at 1:00 at the Desert Hills Social Center.

Prior to the meeting Rebe Philip introduced Jeanne (Gina) Dalsing, and her daughter, who gave a presentation on the *Hands of a Friend* (*Manos Amigas*) *Foundation* and *Genesis House*. Jeanne gave updates on new personnel at the Foundation, and many improvements that have been made to *Genesis House*. Envelopes containing contact and contribution information were passed out. Thank you Jeanne for a very informative presentation.

Following Jeanne's presentation, the meeting was called to order by vice president, Rebe Philip, as Janis Slaughter had another meeting to attend.

REPORTS:

MINUTES: Rebe presented the minutes of the May 5, 2021 general meeting. After a motion by Iris Sapovits and proper second the minutes were approved as presented.

FINANCIAL: Rebe gave the treasurer's report. The ending balance is: \$12,829.72. After a motion by Iris Sapovits and proper second the financial report was approved as presented.

FESTIVAL COMMITTEE: Rebe Philip reported that the dates of the Craft Festival will be February 18 – 19, 2022. Set-up will be on Thursday, February 17 between 3:00 and 6:00 p.m. After that time the doors and gates will be locked for security. Letters will be sent to last year's vendors as soon as the Artisans Festival is concluded in November.

Rebe outlined the vendor requirements: Each vendor must turn in an application before the cut-off date, must be a GVR member, and have a current Arizona Transaction Privilege Tax License and she emphasized that items must be handcrafted by the vendor.

Rebe reported that volunteers were needed at the festival for ticket sales, raffle contributions and drawings, vendor relief, etc and asked those who could to sign up.

MEMBERSHIP: Iris Sapovits reported that there were 18 members in attendance including 3 new members, Katrina Lasko, Lorraine Thomas and Coleen Supancic and 2 visitors – Susan Callender and Laurel Brink. Rebe had the new members and visitors introduce themselves.
